# <u>Notice of Privacy Practices</u> This notice describes how medical, drug, and alcohol related information about you may be used and disclosed and how you can get access to this information. Please review it carefully.

## **General Information**

Information regarding your health care, including payment for health care, is protected by two federal laws; the Health Insurance Portability and Accountability Act of 1996 ("HIPAA"), 42 U.S.C. 1320det seq,, 45 C.F.R. Part 160 & 164 and the Confidentiality Law, 42 U.S.C. 290dd-2, 42 C.F.R. Part 2. Under these laws, New Hope Psychiatry, LLC may not say to a person outside New Hope Psychiatry, LLC that you attend the program, nor may New Hope Psychiatry, LLC disclose any information identifying you as an alcohol or drug abuser, or disclose any other protected information except as permitted by federal law.

New Hope Psychiatry, LLC must obtain your written consent before it can disclose information about you for payment purposes. For example, New Hope Psychiatry, LLC must obtain your written consent before it can disclose information to your health insurer in order to be paid for services. Generally, you must also sign a written consent before New Hope Psychiatry, LLC can share information for treatment purposes or for health care operations. However, federal law permits New Hope Psychiatry, LLC to disclose information without your written permission in the following situations:

1. Pursuant to an agreement with a qualified service organization/ business associate. 2. 'For research, audit or evaluations. 3. To report a crime committed on New Hope Psychiatry, LLC premises or against New Hope Psychiatry, LLC personnel. 4. To medical personnel in a medical emergency. 5. To appropriate authorities to report suspected child abuse or neglect or domestic violence. 6. As allowed by a court order.

For example, New Hope Psychiatry, LLC can disclose information without your consent to obtain legal or financial services, or to another medical facility to provide healthcare to you, as long as there is a qualified services organization/ business associate agreement in place.

New Hope Psychiatry, LLC may need to share your protected health information with third parties that perform various services, such as insurance companies. Whenever an arrangement between our office and a business associate involves the use or disclosure of your protected health information, we will have a written contract that contains terms that will protect the privacy of your protected health information.

Before New Hope Psychiatry, LLC can use or disclose any information about your health in a manner, which is not described above, it must first obtain your specific written consent allowing it to make the disclosure. You may revoke any such written consent in writing at any time.

### Your Rights

Under HIPAA you have the right to request restrictions on certain uses and disclosures of your health information. At your request, New Hope Psychiatry, LLC will not disclose information to your health insurance plan about any services for which you have paid out-of-pocket.

New Hope Psychiatry, LLC is not required to agree to any other restrictions you request, but if it does agree, then it is bound by that agreement and may not use or disclose any information which you have restricted except as necessary in a medical emergency.

You have the right to request that we communicate with you by alternative means or at an alternative location. New Hope Psychiatry, LLC will accommodate such requests that are reasonable and will not request an explanation from you. Under HIPAA you also have the right to inspect and copy your own health information maintained by New Hope Psychiatry, LLC, except to the extent that the information contains psychotherapy notes or information compiled for use in a civil, criminal or administrative proceeding or in other limited circumstances.

Under HIPAA you also have the right, with some exceptions, to amend health care information maintained in New Hope Psychiatry, LLC records, and to request and receive an accounting of disclosures of your health related information made by New Hope Psychiatry, LLC during the six years prior to your request. You also have the right to receive a paper copy of this notice.

#### New Hope Psychiatry, LLC Duties

New Hope Psychiatry, LLC will not share your protected health information for marketing or fundraising purposes, nor will we ever sell your protected health information without your prior approval.

New Hope Psychiatry, LLC is required by law to maintain the privacy of your health information and to provide you with notice of its legal duties and privacy practices with respect to your health information. New Hope Psychiatry, LLC is required by law to abide by the terms of this notice. New Hope Psychiatry, LLC reserves the right to change the terms of this notice and to make new notice provisions effective for all protected health information it maintains. You may access a revised version copy; you may request a copy by calling the office and requesting that a revised copy will be sent to you in the mail or asking for one at the time of your next appointment.

#### **Questions and Complaints**

If you want more information about our privacy practices or have questions or concerns, please contact our office at (308) 237-0391. If you are concerned that we may have violated your privacy rights, or you disagree with a decision we made about access to your health information or in response to a request you made to amend or restrict the use of disclosure of your health information or to have us communicate with you by alternative means or at alternative locations. You may complain to us using the contact information listed at the end of this Notice. You also may submit a written complaint to the U.S. Department of Health and Human Services. We will provide you with the address to file your complaint with the U.S. Department of Health and Human Services upon request.

We support your right to the privacy of your health information. We will not retaliate in any way if you choose to file a complaint with us or the U.S. Department of Health and Human Services.
